



Timor-Leste: the history and development of

This text is a study of how the small Asia-Pacific nation of Timor-Leste has emerged from prolonged conflict and successfully navigated a path to durable peace and sustainable development. The authors provide insights into the reconstruction of a nation and its rapid transformation into a peaceful and democratic state, anticipating that other countries may draw lessons from Timor-Leste's experiences in management of natural resources, empowerment of the vulnerable, and advancement of women.

AGRICULTURE AND ENVIRONMENT

The climate casino: risk, uncertainty, and economics for a warming world. Nordhaus, William. New Haven, CT: Yale University Press, 2013.



Yale economist William Nordhaus believes we are entering the climate casino, as economic growth is producing perilous changes in the climate system. He explores the links between economic activity and climate change, discussing global warming's origins in our personal energy use, and advocates for effective economic policies that

can be enacted to reduce these dangers.


Energy, climate change and environment: 2014 insights (e-book from the OECD iLibrary).


thinking are based on Baban's experiences in arid/semiarid, temperate, and tropical conditions.

Constitutions in authoritarian regimes. Ginsburg, Tom and Alberto Simpser, editors. New York: Cambridge University Press, 2014.



Contributors explore the form and function of constitutions in countries with authoritarian regimes. Case studies representing different forms of authoritarian regimes are presented, providing broader insights into the study of practices such as co-optation and repression; institutions such as legislatures, courts and elections; urces of accountability

and non-democratic sources of accountability.





Understanding Central America: global forces, rebellion, and change. Booth, John A., Christine J. Wade, and Thomas W. Walker. Boulder, CO: Westview Press, 2014.

The authors explain how domestic, global, political and economic forces have shaped rebellion and regime change in Costa Rica, Nicaragua, El Salvador, Guatemala, and Honduras throughout their histories. They explore the origins and development of the region's political conflicts, their resolution and ongoing political change. This second edition provides up-to-date information on the most recent political changes in each of the five countries presented.

World order. Kissinger, Henry. New York: Penguin Press, 2014.



Kissinger reveals his analysis of the ultimate challenge for the twenty first century: how to build a shared international order in a world of divergent historical perspectives, violent conflict, proliferating technology, and ideological extremism. He guides readers though episodes in recent world history, including the Nixon administration's negotiations

with Hanoi at the end of the Vietnam War, and provides insights into U.S.-China relations, the evolution of the European Union, and conflicts in Iraq and Afghanistan.

ECONOMIC GROWTH AND TRADE

Lessons from Latin America: innovations in politics, culture, and development. Arocena, Felipe and Kirk Bowman. Toronto: University of Toronto Press, 2014.

In this text, the common perception that Latin America is an "underdeveloped" region is refuted. Arocena and Bowman explore the ways in which these countries have addressed their respective difficulties, and highlight the innovative approaches that have emerged in areas of cultural rights, inequality, racism, women and politics, social security, and military budgeting.

They argue that the "lessons" learned from these policy and cultural changes within Latin America, including successes, failures, and unintended consequences, should inform policy discussions globally.

New strategies for social innovation: marketbased approaches for assisting the poor.

Anderson, Steven G. New York: Columbia University Press, 2014.

In this book, Anderson assesses emerging market-based social change approaches including: corporate social responsibility, social entrepreneurship, private sustainable development, and fair trade. He identifies the problems these programs address and describes their core, shared principles. Individual chapters provide background on the



> Burde makes the case that humanitarian models often offer limited attention and resources toward education. She examines how humanitarian aid for education has undermined statebuilding efforts in Afghanistan, sowing conflict in the 1980s with an anti-Soviet curriculum, and in the 2000s

though misguided stabilization programs. Incorporating insights gained through extensive fieldwork in Afghanistan and Pakistan, Burde commends recent programs that have produced positive results and contributed to peacebuilding efforts. The work of USAID is discussed in multiple chapters.

GENDER EQUALITY AND WOMEN'S EMPOWERMENT

Gender, war, and conflict.

Sjoberg, Laura. Cambridge, UK: Polity Press, 2014.

How useful are traditional gendered categories in understanding the dynamics of war and conflict? Sjoberg explores this question and reveals how gender matters in the making and fighting of wars today. Based on examples from conflicts

throughout the world, she argues that both women and men play more diverse roles in wars than either the media or traditional scholarly accounts convey.

This report provides a comparative overview of the policies affecting women's participation in public life across the Middle East and North Africa region. It analyzes the existing legal barriers for gender equality in public life, with regard to political and economic rights, freedom of movement, labour law, family law, access to justice and gender-based

Based on the experiences of three East African countries—Uganda, Tanzania and Kenya—the book outlines each country's experience in building and sustaining multistakeholder coalitions to drive reforms in the health sector. The authors show that coalitions have powerful potential to bring important health system benefits to governments and the citizens they serve. This book

It sets out a vision for the future, showing how new relationships can be created with international



The study of treatment and diagnosis of communicable diseases is examined alongside
