Aid in danger: the perils and promise of humanitarianism. Fast, Larissa. Philadelphia: University of Pennsylvania Press, 2014.

Fast critically examines the causes of violence against humanitarian aid workers and the consequences of the approaches aid agencies use to protect themselves from attack. She argues that most explanations of attacks locate the causes externally and maintain an image of aid workers as an exceptional category of civilians, ignoring the internal vulnerabilities that sometimes contribute to the conditions leading to

violence. Fast explores both external threats and internal vulnerabilities, detailing the challenges of providing aid in perilous settings.

Help or harm: the human security effects of international NGOs. Murdie, Amanda. Stanford, CA: Stanford University Press, 2014.

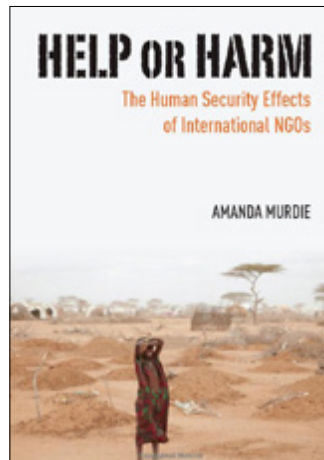

What explains when and where INGOs will be successful at improving human security? Testing her theory through case-studies of over 100 countries that have exhibited imperfect human security situations since the end of the Cold War, Murdie argues that differences in organizational characteristics--reflecting

underlying motivations, issue-focus, and state peculiarities--determine when and where the growing force of INGOs will be effective contributors to human security outcomes.

In a new chapter on post-development models, Rist argues that development has been no more than a collective delusion, which in reality has only resulted in widening market relations.

Taking a systems approach, contributors analyze case studies from 26 countries and identify common barriers and bridges for local adaptation to climate change through water resources

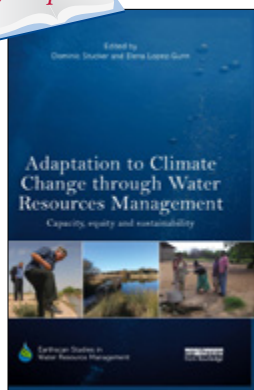

Copnall, James. London: Hurst & Company, 2014.

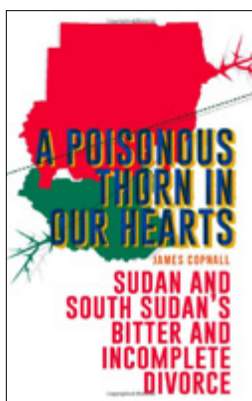

Fukuyama, Francis. New York: Farrar, Straus, and Giroux, 2014.

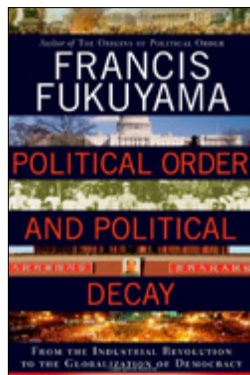

why some societies have been successful at rooting it out and highlights the struggle to create a well-functioning modern state.

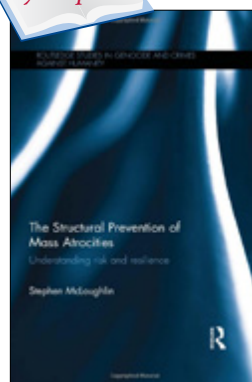

McLoughlin, Stephen. Abingdon, Oxon ; New York: Routledge, 2014.

Most current research emphasizes identifying and ameliorating the "root causes" of mass atrocities, however McLoughlin believes this type of focus neglects the reasons why violence does not occur in all countries that contain the

presence of these root causes. Focusing on the causes of peace and stability within vulnerable nations, he analyzes Botswana, Zambia, and Tanzania, exploring the processes and dynamics these countries have used to build resilience and mitigate the risk of mass atrocities.

Working with the grain: integrating governance and growth in development strategies. Levy, Brian. New York: Oxford University Press, 2014.

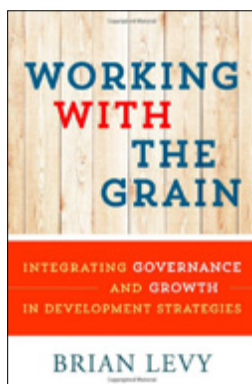

As an alternative to the “best practices” approach to governance reform that has dominated the development discourse in recent decades, Levy provides policymakers, donors, civil society activists, and other development practitioners a practical, analytically grounded, “with-the-grain” approach to governance reform and development policymaking.

He examines how institutions, politics, and economic policy interact with one another and encourages the exploration of possibilities that respond creatively to the governance ambiguities of our early twenty-first century world.

ECONOMIC GROWTH AND TRADE

Creating a learning society: a new approach to growth, development, and social progress.

Stiglitz, Joseph E. and Bruce C. Greenwald. New York: Columbia University Press, 2014.

To help countries grow and close the gap in knowledge that exists between developed from less-developed countries, it is essential to know how they learn and what government can do to promote learning. Stiglitz and Greenwald show how well designed government trade and industrial policies can help create a learning society, and propose that free trade may lead to stagnation whereas broad-based industrial protection and exchange rate interventions may bring benefits to the entire economy.

Today, membership in village-level savings groups totals over 10 million members. Ashe and Neilan illustrate how savings groups form and function in developing countries, increasing food security, building assets, and empowering the community. Ashe details his personal experience with the Saving for Change initiative, which leveraged the wisdom and strength of group members to train and establish new savings groups.

Land's end: capitalist relations on an indigenous frontier. Li, Tania Murray. Durham, NC: Duke University Press, 2014.

Drawing on two decades of ethnographic research in Sulawesi, Indonesia, Li offers an account of the emergence of capitalist relations among indigenous highlanders who privatized their common land, an action initiated by farmers rather than coerced by the state or agribusiness corporation, to plant a boom crop, cacao. Li provides insight into the highlanders' world, exploring the dilemmas they faced as sharp inequalities emerged among kin and neighbors, as some prospered while others lost their land.

Understanding Changes in Poverty (e-book from the World Bank eLibrary).

Authors examine the causes behind the movement in poverty reduction from simple approaches, including changes in demographics, employment, earnings, and public transfers, to complex approaches, such as changes in individual and household characteristics. Contributors explore the development of intercultural bilingual education throughout Latin America, resulting from the endorsement of Indigenous peoples' rights. Through case study analysis, the authors explore how social change, as a result of local movements and transnational networks, is taking place and allowing for the inclusion of cultural, ethnic, and linguistic diversity in Latin American education systems.

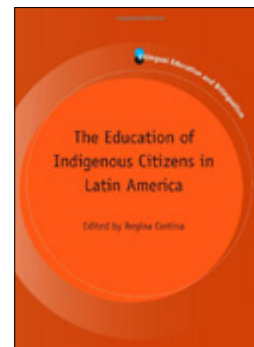

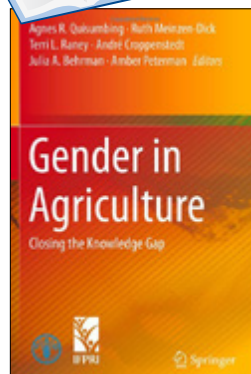

This book builds on the 2011 Food and Agriculture Organization of the United Nations (FAO) report on women in agriculture which had concluded that women, who constitute half of all farmers, lack equal access to the resources and opportunities they need to be more productive. The authors

provide a more thorough examination of the conceptual and empirical basis of the FAO report, and propose ways to address the disadvantages and inequities that burden women farmers.

Why gender matters in economics. Eswaran, Mukesh. Princeton, NJ: Princeton University Press, 2014.

This textbook provides an economic look at issues confronting women throughout the world-- including nonmarket scenarios, such as marriage and fertility choices, as well as market areas, pertaining to labor and credit markets and globalization. Eswaran examines the ways in which economic outcomes differ for women and men and explores the consequences of these differences in both market and nonmarket domains, including changes occurring as a result of women's increased access to healthcare, education, and credit.

This book provides evidence of the impact of climate change on global health. 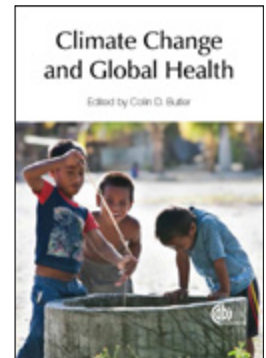

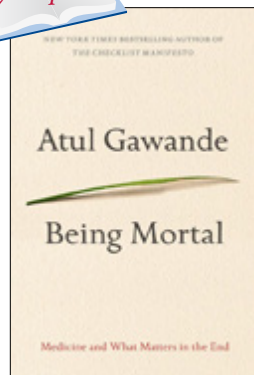

Falleiro, Savio P. New Delhi: Sage Publications, 2014.

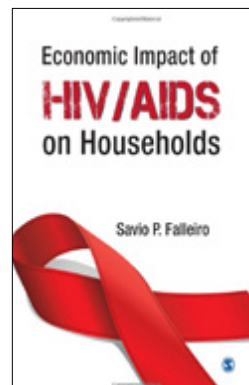

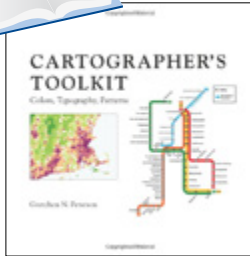

- ▶ **New Book alerts** – Subscribe to the *New This Month* newsletter to receive updates on the latest print and e-books added to the Library collection
- ▶ **News alerts** – Follow any newspaper publications and/or stories on a monthly, weekly, business daily, or daily basis
- ▶ **Subject alerts** – Subject alerts allow you to be notified when articles are published that match your subject criteria. This service is available in databases such as *Academic Search Elite*, *JSTOR*, *OECD iLibrary*, *ScienceDirect*, *Web of Science*, and many others
